# **Designated Tournament Reports:**

Lewis & Clark: passed out entry; extra prep time for policy teams; novice can enter one per pattern; junior/senior two per pattern; make hotel reservations early.

U of Oregon: experimental event on "forensics criticism" will be added. Students can enter the experimental event in addition to "two per pattern" in other events; The event is a 10 minute memorized speech offering constructive criticism of some aspect of forensics competition; novice parli will have a topic area to be announced later.

Western Washington not present; sent a one-page summary of their tournament.

Whitman brought a copy of their entry; students who are not competing may be used as judges in emergency situations;

### Policy Discussions (tamest in conferest history...)

### Novice and junior eligibility:

A discussion was held without new policies. Some of what was said: novice definitions vary from organization to organization – NDT, NPDA, CEDA; there needs to be a consciousness-raising so that coaches enter students in appropriate divisions;

Division I, Division II, Division III

A proposal from Trischa Knapp was discussed and unanimously tabled. That proposal would have changed the way schools were assigned to divisions.

A new committee was formed to continue studying this issue. The committee is chaired by Al Golden. A new committee was formed to examine novice, junior, open divisions. This committee is chaired by Jim Hanson with Brent Northup also serving on the committee.

# Community College presence in the Designated Tab Rooms.

Craig Rickett, community college representative, reminded coaches of the "aspiration" passed some time ago to include community college coaches in the tab rooms of tournaments. This was another "consciousness-raising" suggestion, without changes in policy.

# **IE Finals Proposal:**

A bylaw change was passed insuring that the number of students in the final round senior division of an individual event is equal to or greater than the number of NIET legs given in the event.

### **Proxy voting**

There was discussion of how to handle proxy voting at NFC meetings. Brent Northup agreed to study the issue and report back with how it is handled in other organizations.

## Coaching during prep

A lengthy, cordial discussion was held concerning the practice of "coaching parliamentary debaters during their prep time." Every coach, in turn, expressed their position on this issue. The positions ranged from opposition to any contact to support for actually assisting in preparation for the debate. Informally, there appeared to be a strong majority opposing a ban on contact during prep time, but there were also many coaches who would limit/restrict what could be said in such circumstances (giving directions to buildings is fine; defining FAST\_TRACK might be OK; writing a case for the team might not be fine; and so forth)

#### CEDA. Jim Hanson.

New Northwest CEDA rep being chosen soon; Whitman has formed a database of all U.S. debate programs for use by high school students and others. It can be accessed from the Whitman web page whitman/rhetoric/forensics/forensics friends.
