



2018 Texas Tech University/University of Utah Mile High Swing

Dear Colleagues:

The forensic programs at Texas Tech University and The University of Utah invite you to the 12th annual Mile High Swing to be held on the campus of The University of Utah, January 4-7, 2018. We are also pleased to announce that Joe Gantt, Director of Forensics at Lewis & Clark College, has agreed to tabulate the tournament. PLEASE NOTE: This year, the tournament will run over 4, not 3, days.

The Mile High Swing will feature 2 complete parliamentary debate tournaments. At the first half (TTU), we will offer 5 preliminary rounds with a double-octafinal break consistent with the NPTE, along with some other features similar to the NPTE, such as pre-released topic areas. At the second half (Great Salt Lake), we will offer 5 preliminary rounds with a possibility of partial triple-octofinals, and we will utilize random topics similar to the NPDA Championship tournament. The first half will utilize mutual judging; the second will utilize strikes. Both tournaments will feature two minutes of flex-time after the PMC and LOC, as well as one minute of flex time after the MGC and LOR. This time may be used for prep, CX, drinking water, etc.

We expect these tournaments to be some of the most competitive in the nation and we hope you will join us in Salt Lake City this coming January.

All attendees are welcome to join us at the reception. Likewise, the hotel offers a downtown shuttle for those wishing to make dinner arrangements, etc.

Tournament Procedures & Facilitation

Unless otherwise specified, NPDA tournament guidelines will govern the tournament's operating procedures. The tournament directors reserve the right to make any decisions necessary to facilitate the timely and accurate completion of the tournament.

Entries & Eligibility

Tournaments are open to any regularly enrolled undergraduate in a two year or four year college or university in good standing with the school's debate team/club. As the tournaments run back-to-back, students may (and are encouraged to) attend both tournaments.

All entries should be submitted via the forensicstournament.net website. Please make sure that you <u>enter both halves</u> of the swing, if that is your choice. **Entries are due by Thursday, December 28**th at 11:59 PM (PST). This early entry deadline is necessary for ordering food, compiling judges, and ensuring the timely distribution of strike forms.

Please Note! In addition, <u>all judges must enter a judging philosophy on</u> forensicstournament.net by Thursday, December 28th at 11:59PM (PST). Schools that fail to enter their judge's philosophies will forfeit the right to complete preferences/strikes AND/OR BE REQUIRED TO PAY A NUISANCE FEE. We hate to make threats concerning philosophies, but we are concerned by the need for the tournament to scramble and prod schools for philosophies. Please enter philosophies when you enter your judges to ensure that other schools have access to information so that they can make appropriate decisions concerning their preferences.

<u>Campus</u>

The tournament will make every effort to minimize the length of walks on campus. Prep rooms will be randomly assigned by size of squad and space needs.

Parliamentary Debate- 1st Half (TTU)

Five preliminary rounds of parliamentary debate will be offered followed by double-octafinals in one open division. Competition will be administered according to the NPDA rules of Judging and Debating. Time limits are 7 minutes for the 1st government constructive, 8 minutes for all other constructive speeches, 4 minutes for the leader of opposition rebuttal, and 5 minutes for the prime minister rebuttal.

SPECIAL NOTE: Both tournaments will feature two minutes of flex time after the PMC and LOC, as well as one minute of flex time after the MGC and LOR. This time may be used for prep, CX, drinking water, etc.

Pre-Released Topic Areas (TTU Half Only)

Topics will be selected from a list of 5 controversy areas released approximately on or about November 25, 2017. We recognize that the vast majority of schools will have either just completed their winter break or may still be on winter break at the time of the swing; therefore, allowing one month (or more) of time to review the topic areas and resolutions will allow for all students to have some opportunity to conduct research.

Advancing to Elimination Rounds

At the end of the preliminary rounds, we will, consistent with NPTE practices, advance all teams with a winning record (3-2 and better) up to a full double-octafinal; *a partial elim will not be held at this half*. Teams advance first based on win/loss record, then adjusted speaker points, then total speaker points, then judge variance. Brackets will be broken in elimination rounds.

Mutuality-based Judging

At this half of the tournament, we will offer mutual judging. All judge ranking information must be submitted by Wednesday, January $3^{\rm rd}$ at 6:00PM PST in order to be guaranteed for the first two rounds of competition.

Forfeiture Rule: Any team that is late to a round will have that time deducted from their team's first speech (the PMC or LOC). When the full speech time has elapsed (7 or 8 minutes), the team in question will be forfeited. In the event both teams are late, both teams will have time deducted from their first speech. A universal timer will be made available at the time of topic announcement. Time deductions and forfeiture rules will be enforced by the judge assigned to the round.

Centralized Topic Announcement (BOTH TOURNAMENTS)

Topics, during the tournament, will be released at a centralized announcement site and teams will have 20 minutes to prepare and walk to their room. We will assign a preparation room for each squad. We are on a very tight schedule, so it is imperative that rounds begin on time! Parliamentary Debate- 2nd Half (Great Salt Lake)

All tournament guidelines are the same as for the Texas Tech half, with the exception of two things; at the GSL half, there will be no topic areas (though topics from the TTU topic areas may be used) and mutuality-based judging will not be utilized.

SPECIAL NOTE: Both tournaments will feature two minutes of flex time after the PMC and LOC, as well as one minute of flex time after the MGC, and LOR. This time may be used for prep, CX, drinking water, etc.

Advancing to Elimination Rounds

At the end of the preliminary rounds, we will advance all teams with a winning record (3-2 and better) to elimination rounds, including a partial triple octafinal round. Teams advance first based on win/loss record, then adjusted speaker points, then total speaker points, then judge variance. Brackets will be broken in elimination rounds.

Judge Strikes

An appropriate number of judge strikes will be available. Once again, judge strikes need to be submitted by Wednesday, January 3rd at 6:00PM PST in order to be guaranteed for the first two rounds of competition. **WE WILL USE EMAIL BALLOTING!**

Forfeiture Rule: Any team that is late to a round will have that time deducted from their team's first speech (the PMC or LOC). When the full speech time has elapsed (7 or 8 minutes), the team in question will be forfeited. In the event both teams are late, both teams will have time deducted from their first speech. A universal timer will be made available at the time of topic announcement. Time deductions and forfeiture rules will be enforced by the judge assigned to the round.

Awards

Individual awards will be presented to the top 10 speakers in each tournament. Because we value meaningful awards for top performances, quality awards (one per team) will be presented to all teams who advance to the quarterfinal round and beyond. Additionally, we will present a swing sweepstakes award to the top three schools at the combined two tournaments. Swing sweepstakes will be determined by awarding 1 point for every preliminary round win for a school's top four teams at each tournament. Ties will be broken in favor of the school whose team advanced farthest at the first half of the swing. We will also have a special award for the top speaker at both halves combined.

The award for top speaker and top team at the GSL half honor two of Utah's emeriti faculty in argumentation & debate. First, the Malcolm O. Sillars Tournament Champion Award will be given to the team that wins the Open division of NPDA at the GSL. Second, the Richard Rieke Outstanding Debater award will be given to the top ranked speaker in the Open division of the GSL

Fees

For the 2018 tournament, we are adjusting fees to better reflect the costs of the tournament and their variation depending on the size of judging/coaching staff that attends with teams. We are accomplishing this by drastically reducing the "per team fee" (by 30%) and adding a nominal per person fee. Fees structures will remain identical at both halves of the tournament, as in past years. These fees include meals as indicated in the schedule, as well as light snacks and coffee throughout the tournament.

**Fees will be assessed as of 11:59 PM PST, Thursday, December 28th and schools will be expected to pay fees as indicated by their entry at that time regardless of subsequent deletions.

Fee Structure (per half):

\$70.00 Team Fee

\$15.00 Per Person Fee (required for every competitor, judge, observer, or coach) \$150 Per Uncovered Team

Community College Fee Reduction

The University of Utah and Texas Tech University support the involvement of community colleges in competitive forensics both through our recruitment efforts and our outreach. Consistent with those efforts, all community college teams that cover their judging commitment will receive a fee reduction from their total fees (excluding uncovered judging fees).

A note on uncovered judging:

It's cliché, but we would rather have your judges than your money. The tournament directors reserve the right to refuse entry to teams uncovered by a critic. If you have extra judges attending the tournament, please contact the tournament directors, as we may be able to hire them at a healthy stipend.

Judging Obligation

Judges will be expected to judge all preliminary rounds and thru the doubleoctofinal round. After that point, judges will be expected to judge one round past the elimination of their teams.

Driving Directions

From the Airport: Out of airport, follow signs toward Park City/Cheyenne. You will pass through downtown on the freeway as it curves right and then left. When you arrive at 1300E, exit the freeway and turn left onto 1300E. Go north until you reach 400S and turn right at the southwest corner of campus. Follow this street onto the U of Utah campus. The street passes by the Rice Eccles Football Stadium. Take a left at the second light once you turn right on 400S, following signs to the Marriott Library. Once parked, look for the Social & Behavioral Sciences (BEH S) building (it is a large tower on the south side of the library). Parking fees will be assessed by the University on Friday; the weekend is free in any lot, unless otherwise marked.

From the Hotel: From the Hotel RL, turn right out of the parking lot onto 600 South. Follow 600 South and turn left onto State Street. Continue forward until you reach 400 South and turn right. Continue on 400 South, noting that it will curve to the right and then to the left as you head up the hill. When you reach the top, turn left onto 1300 East. Take 1300 East until you reach 400 South; turn right turn right at the southwest corner of campus. Follow this street onto the U of Utah campus. The street passes by the Rice Eccles Football Stadium. Take a left at the second light once you turn right on 400S, following signs to the Marriott Library. Once parked, look for the Social & Behavioral Sciences (BEH S) building (it is a large tower on the south side of the library). Parking fees will be assessed by the University on Thursday & Friday; the weekend is free in any lot, unless otherwise marked.

From Airport to Hotel: Exit the airport and head on I-80 east toward downtown/Park City/Cheyenne. You will curve through downtown reaching an exit for 600 South. Exit here. Immediately upon exit you will see the Hotel RL to your right as you head east on 600 South.
