Due to room space, there will not be a novice division, but top novices in each event will be recognized. A novice is defined as any student in their first year of intercollegiate competition.

We will have a hospitality room for judges and coaches. We will also have a sandwich making station with fruits, water, and snacks for competitors.

The sweepstakes formula is as followed: 10 points for 1st place, 8 points for 2nd place, 6 points for 3rd place, 4 points for 4th place, 2 points for 5th place, and 1 point for 6th place. The same formula will be used for individual sweepstakes awards for students in four events.

Nondiscrimination and Equal Opportunity

Drugs, Alcohol, and Cohabitation Policy

The Aztec Invitational is an education activity that promotes critical thinking, teamwork, and public speaking in a safe environment. Thus, it is the policy of the tournament that all students and competitors refrain from illicit drug and alcohol use over the tournament weekend. The tournament also does not condone the cohabitation of multiple schools.
